- make a deposit of €100 in the case of an election of members of a county or city council or €50 in the case of any other election (deposit may also be made on the candidate's behalf).

Details of these requirements are set out in the Electoral (Amendment) Act 2009.

**The latest time for receiving nominations is 12 noon on the 16th day of May, 2009.**

Completed nomination papers may be delivered to me in person by the candidate or his/her proposer at any time when I am at my office, from 10am on the 9th day of **May, 2009** until 12 noon on the last day for receiving nominations.

I am required by law to attend to receive nominations between 10am and 12 noon and between 2pm and 5pm on the **15th day of May, 2009** and between 10am and 12 noon on the **16th day of May, 2009.**

If the election is contested, a poll will be taken on the **5th day of June, 2009** between the hours of 7 am and 10 pm.
