Notice is hereby given that Carlow County Council has, pursuant to the provisions of the above Act and Regulations, prepared a Draft Tullow Local Area Plan for the period 2016 – 2022.

The Draft Local Area Plan is accompanied by an Environmental Report, prepared in accordance with the Planning and Development (Strategic Environmental Assessment) Regulations 2004-2011 and an Appropriate Assessment, pursuant to Article 6 of the Habitats Directive 92/43/EEC. A Strategic Flood Risk Assessment also accompanies this Local Area Plan document.

Submissions and observations in relation to the Draft Tullow Local Area Plan 2016 - 2022 are invited during the public consultation period, from **9.30 a.m. Wednesday 27th July, 2016 to 5.00 p.m. Wednesday 7th September, 2016**. Submissions/observations should state the name and address of the person/organisation making the submission/observation. Submissions/observations may be made in writing to The Forward Planning Section, Planning Department, Carlow County Council, Athy Road, Carlow or by email to LAP@carlowcoco.ie. Submissions/observations should be clearly marked 'Draft Tullow Local Area Plan 2016 - 2022'. Please note that late submissions will not be considered.

Please note the following when making a submission/observation:

- Submissions/observations regarding objectives and policies to deliver an overall strategy for the proper planning and sustainable development of the land within local area plan may be made
- Children or groups or associations representing the interests of children are entitled to make submissions or observations regarding objectives and policies to deliver an overall strategy for the proper planning and sustainable development

- Submissions and observations may be made available to the public
- Carlow County Council is subject to the provisions of the Freedom of Information (FOI) Act. You are asked to consider if any of the information supplied by you in your submission/observation should not be disclosed because of its sensitivity. If you consider that certain information is not to be disclosed because of its sensitivity, you should, when providing such information, clearly identify same and specify the reasons for its sensitivity. If you do not identify it as sensitive, it is liable to be released in response to a Freedom of Information request without further consultation with you. The Local Authority will, where possible, consult with you about sensitive information you have identified before making a decision on a request received under the Freedom of Information Acts. If you consider that none of the information provided by you is sensitive, please make a statement to that effect
- Carlow County Council is subject to the provisions of the Data Protection Act. In order to assist Carlow County Council in complying with the Data Protection Act please include your name and contact details on a separate page to the content of your submission/observation
