ENVIRONMENTAL / AMENITY IMPROVEMENTS:

Qualifying works include:

- Landscaping and development of open spaces (trees, shrubs, flower-beds, planters, paving, etc);
- Repair and improvement to grottos, monuments and old stone walls (on a small scale);
- Amenity development on river/stream banks;
- Any other environmental initiatives which comply with above criteria;
- Environmental protection and enhancement including promotion of Biodiversity, recycling /waste minimisation, water harvesting;
- Any other works of a general nature which will enhance the overall appearance or reduce litter.
