GUIDE LINES

Ethos & Focus of Grants

The purpose of *the Individual Arts Grants Scheme 2018* is to assist local Artists who would benefit from this support or to develop a particular project. Applications will not be accepted from statutory bodies. Only one application from any individual will be considered.

Aims and Criteria of the Individual Arts Grants Scheme

The aim of this Fund is to support Individual Artists in County Carlow that will support

- The on-going practice of Artists to enable them to:
 - Realise an exhibition,
 - Publish work
 - Attend a professional development course
 - Allow for artistic time and space to develop their work
 - Realise a show, performance or piece of theatre or film.
- Artists can work in any of the following disciplines: Visual Art, Music, Dance, Performance, Theatre, Film and multi-media, Composers, Circus/street arts, Traditional Arts, Social Engaged arts etc.

Eligibility – Please Note

- The maximum award under this scheme is €3,000
- Please note that only 75% of your total budget, if successful will be awarded to you. No applicant will receive the full 100% budget proposed therefore evidence must be shown about how you will self-finance the 25%
- If you intend engaging an invited artist to work with you, you are required to include their fee in your budget breakdown
- Copy of income and expenditure from last year must be submitted with application form
- On completion of the project, invoices, receipts together with photographs must be submitted prior to payment
- Where a grant is allocated for a specific project Carlow County Council will not be responsible for the insurance of that project. Nor will Carlow County Council be responsible for your compliance with Child Protection Policies if activities are involving children and young people (0-18yrs). Carlow County Council recommends that the organisers have appropriate insurance cover in place prior to the commencement of a project. Where a project includes a large gathering of people Carlow County Council recommends that the organisers ensure that an Event & Safety Management Plan, Litter Management Plan and Traffic Management Plan as appropriate is in place.
- **You are only entitled to apply for one Grant Scheme across all departments of Carlow County Council within one calendar year**
- **Festivals and Events are not eligible under this scheme**

Provide information on all sources of income relevant to your proposed activity for example evidence is to be clearly shown of how much you are seeking from the County Council and evidence shown of all other income streams associated with the proposal.

Earned Income means income created from ticket sales, catalogue / programme sales etc.

Income in Kind means services or goods offered to you, i.e. if someone is willing to design posters for you for free, donate wine for the preview etc. the value of this income in kind is the price of that service had they not offered to drive you for free.

Other Income means monies you have been awarded from other grant giving organisations, sponsors etc.

Application to Carlow County Council means the amount of money you require from us to undertake this activity.

Give a breakdown of all costs, i.e. how you reached each subtotal including funding in kind.

Itemise the cost of publicising your activity if applicable.

Itemise mail outs, phone calls and administration.

Itemise any journeys associated with your event and give details.

Itemise any items you may need to buy especially to undertake this project.

Itemise how you will evaluate your event and the cost of recording this self-evaluation.

Assessment of application will include an itemised Project Budget e.g.: If you are applying for a grant of €500 we require evidence of how you arrived at this amount. Therefore a detailed breakdown of costs is required. PLEASE ITEMISE ALL YOUR COSTS.
