**Notice of Alteration to Proposed Amendment No. 1 to Joint Spatial Plan for the Greater Carlow Graiguecullen Urban Area 2012-2018 incorporating the Carlow Town Environs Local Area Plan 2012-2018**

**Notice is hereby given**, pursuant to Section 20 (3)(e) of the Planning and Development Act 2000, as amended (hereafter the Act), and Article 14G of the Planning and Development (Strategic Environmental Assessment) Regulations 2004 - 2011 that Carlow County Council has prepared an **Alteration (also known as material alteration)** to the proposed Amendment No. 1 to the Joint Spatial Plan for the Greater Carlow Graiguecullen Urban Area 2012-2018 incorporating the Carlow Town Environs Local Area Plan 2012-2018.

The Alteration is to increase Land Parcel No. 1 from 0.23 hectares to 0.47 hectares.

A copy of the alteration to proposed Amendment No. 1 to the Joint Spatial Plan for the Greater Carlow Graiguecullen Urban Area 2012-2018 incorporating the Carlow Town Environs Local Area Plan 2012-2018, may be inspected during normal public opening hours from **Tuesday 1<sup>st</sup> September, 2015 to Tuesday 6<sup>th</sup> October, 2015 at the following locations from Monday to Friday (excluding Bank Holidays) during normal public opening hours:**

- **Carlow County Council, Athy Road, Carlow**
- **Carlow Library, Tullow Street, Carlow**

Carlow County Council has determined that a Strategic Environmental Assessment (SEA) and an Appropriate Assessment (AA) are required to be carried out in compliance with Section 20 (3)(f) of the Planning and Development Act, as amended, with respect to the Alteration to the Proposed Amendment No. 1 to the Greater Carlow Graiguecullen Urban Area 2012-2018 incorporating the Carlow Town Environs Local Area Plan 2012-2018. These assessments will be completed within 8 weeks of the date of this notice and will take into account any submission made on the Alteration and this determination.

Written submissions or observations relating to the Alteration to Amendment No. 1 to the Joint Spatial Plan for the Greater Carlow Graiguecullen Urban Area 2012-2018 incorporating the Carlow Town Environs Local Area Plan 2012-2018, including the SEA and AA determination, may be made to the **Planning Department, Carlow County Council, Athy Road, Carlow or e-mailed to [jsp@carlowcoco.ie](mailto:jsp@carlowcoco.ie) before 5.00pm, Tuesday 6<sup>th</sup> October, 2015.** All submissions/observations to be clearly marked ***“Alteration to Proposed Amendment No. 1 to the Joint Spatial Plan for the Greater Carlow Graiguecullen Urban Area 2012-2018 incorporating the Carlow Town Environs Local Area Plan 2012-2018”***
