Please find outlined below details concerning the operation of the bring-centres:

1) **Advertising**

- IFFPG will be responsible for all advertising relating to bring-centres
- Bring-centres will be promoted through a combination of media, i.e. national & local newspapers, local IFA branches, IFFPG website etc.

2) **Insurance**

- IFFPG, through the public liability insurance of our approved contractor, will take full insurance responsibilities for operating the bring-centres (see attached insurance certificate)

3) Operation / Clean Up

- IFFPG will be responsible for operating and cleaning up the bring-centres.
- IFFPG, through our contractor, will meet with Site Managers before and after bring-centres are held
- IFFPG will commit 4 staff to each bring-centre.
- IFFPG will only accept uncontaminated plastic at bring-centres.
- IFFPG will take ownership of plastic from the point when it is received from farmers.
- IFFPG is committed to removing as much plastic as possible from bring-centres on the day of operation to Eamon Nolan's permitted waste facility (see attached waste permit).
- Any remaining plastic will be removed at latest within one day of bring-centre been held.
- IFFPG will implement appropriate traffic management for sites in question.
