### 2. BUSINESS PRESCRIBED BY STATUE, STANDING ORDERS OR RESOLUTIONS OF THE COUNCIL

#### (a) Filling of Casual Vacancy by Co-Option

Members had notification from Eamonn Brophy regarding the filling of Casual Vacancy by Co-Option in the membership of Carlow County Council due to the retirement of Michael Abbey on 12th December 2013.

# Proposed by Councillor T. O'Neill Seconded by Councillor F. Browne And

#### It was unanimously resolved:-

"That we, the Members of Carlow County Council hereby approve the appointment of Eileen Brophy to the casual vacancy of Carlow County Council following the retirement of Michael Abbey in accordance with the Local Government Act 2001(as amended) Section 19 (3) (a).

Members congratulated Councillor Brophy on her appointment and welcomed her to the chamber.

Members, on behalf of their fellow political party members, paid tribute to Councillor Brophy. They described her role as a difficult role filling the vacancy created by Michael Abbey's retirement but said she also possessed a wealth of political experience and with her work at the Delta Centre and other agencies she will be a great asset to the chamber. Members described Councillor Brophy as an outstanding talent with integrity, an innovator and hard worker.

The Chairman also welcomed Councillor Brophy saying her appointment is a great asset to the Chamber.

Councillor Brophy thanked the Cathaoirleach, County Manager and fellow Members for their good wishes. She said it was a great honour to fill the vacancy created by Michael Abbey who represented everything that is good in politics, was a great mentor with a passion for politics and for his county. She spoke of the determination and community spirit that exists in Carlow despite the recessionary times and looked forward to working with the people of Carlow in bringing Carlow to the fore.

She thanked her Fine Gael colleagues for their support and Michael Abbey for his mentoring. She said she will give of her best for the betterment of County Carlow and regretted the demise of Carlow Town Council.

## (b) Agree date between 27th January, 2014 and 31st January, 2014 Workshop Review of County Development Plan

A discussion took place in relation to date for Workshop Review of County Development Plan with Members raising the following issues.

- Draft Landscape Character Assessment. Members queried if Draft report will be prepared by 31st January as previously advised and the opportunity for Members to engage with consultants prior to workshop. The County Manager advised it is hoped the Draft will be prepared by 31st January or soon after this date. The consultants are CAAS-Ltd.
- Eirgrid submission. Members requested the submission, approved by Members, be circulated for their consideration. The County Manager advised that the closing date for submission was 8th January and as one submission was made representing a number of groups in County Carlow there was difficulty downloading large volumes of documentation. Access to the documentation is to be arranged for Members.
- Wind Turbines. Members discussed proposal for notice of motion to be submitted in relation to Wind Turbines at Workshop Review of County Development Plan. Members requested copy of Draft Wind Energy Guidelines published by the Department and copy of An Bord Pleanala Report refusing permission for wind turbines in County Offaly. The

County Manager advised that Wind Turbines can not be banned from the County Development Plan.

Members said people power can effect change but acknowledged that any proposed submission in relation to Wind Turbines must have regard to National Guidelines.

In response to Members query the County Manager advised that Local Area Plans will also be considered and brought back to Council.

It was agreed that two or three representatives from each party group meet with Mr. Conor Skeahan of CAAS Ltd to discuss Members issues and proposals.

The agreed date for Workshop Review of County Development Plan is Monday 3rd February, 2014 at 2.00p.m

Members noted Circular Letter PS 21/2013 addressing a number of planning issues relating to the transfer of these functions to Irish Water from 1st January 2014.

#### 5. (b) Update of Irish Water

Mr. J. Carley gave an update on Irish Water. Mr. Carley advised that Carlow County Council signed a service level agreement with Irish

Water at the end of 2013. Carlow County Council will provide water services including water and waste water on behalf of Irish Water on an agency basis with effect from 1st January 2014. Irish Water has commenced a water metering programme across the Country. Metering will commence in Carlow in mid March. Members raised the following issues:-

- €50m in consultancy fees. Members requested that Carlow County Council write to Irish Water for clarification on spending. The County Manager said the targets achieved by Irish Water in a demanding time frame was significant and could not have been achieved in any other country.
- Free water allocation per household and costs per household.
   Members requested that this Council write to Irish Water for information and clarification on these issues.
   Mr. Carley advised that water charges will be set by the Commission for Energy Regulation (CER) and will be guided by Government decision on how much free water will be allowed per house and on how much income Irish Water will need to operate the network.
- Installation of water meters, leak detection and maintenance.
   Mr. Carley advised that Irish Water have set up a public helpline for any issues people may have. The County Manager advised of Irish Water first fix leak policy.
- Grants for upgrade of Septic Tanks. Mr. Carley advised of low failure rate under the National Inspection Plan. To qualify for grant you must be registered and satisfy certain income limits. There are no proposals to inspect septic tanks on demand. Members also queried if grants are available for those with septic tank systems to tap into public sewerage systems.
   Mr. Carley advised that Planning Authorities have to comply with EPA Code of Practice for septic tanks and have due regard to Guidelines.

- Group Sewerage Schemes. Mr Carley advised that the 2014 allocation has not yet been received.
- Vesting date for transferring of assets. Mr. Carley advised of varying vesting dates for particular assets.

# 5.(a) Amendment to Waste Management (Prohibition of Waste Disposal by Burning) Regulations 2009 Extension of farming exemption to January 1st 2016

Members had report from J. Carley on Amendment to Waste Management (Prohibition of Waste Disposal by Burning) Regulations 2009. The 2009 Regulations have been extended until 1st January 2016.

Queries raised by Members were addressed by Mr. Carley.

In response to Members query in relation to burial grounds Mr Carley advised there are no proposals to change current bye-laws.

## (a) Review of Housing Adaptation Schemes for older People and People with a Disability

Members had report from T. Butler on changes to housing grant schemes for the following;

- Housing Adaptation Grant for People with a Disability
- Mobility Aid Grant
- Housing Aid for Older People

Members expressed dissatisfaction with the following changes to the grants schemes;

- All household income is now to be included in assessment.
- Income bands are reduced with the maximum threshold of €60,000 and in the case of Mobility Aid Grants gross annual income of €30,000.
- Maximum grants payable have also been reduced.
- Housing Aid for Older People age limit increased from 60 to 66 years. Members requested that this Council write to the Minister Housing and Planning requesting that this increase be reversed.

Members complimented Mr. Butler and the Housing Staff for the compassion they show people when administering the Grant Schemes.

Members also raised issue of claw back in relation to grants, repairs to windows and doors and Tenant Purchase Scheme.

Issues raised by Members were addressed by Mr. Butler.

#### Members noted notice of motion from Leitrim County Council

"That Leitrim County Council call on the Government and Minister Phil Hogan to withdraw their proposal to introduce a levy on all vacant commercial premises. The pending Local Government legislation, which is due to come into effect in 2014, refers to changing the current process of waiving 100% of the commercial rates on business properties that are vacant and proposes to introduce a levy of 50% of the full rates payable on all properties that are vacant. This new proposal is referred to in "Part 5, Section 31" of the pending legislation. This proposal, to bill all vacant commercial properties in Leitrim and all over the country at 50% of the full rates payable, is unacceptable and unthinkable."

Member noted correspondence from Caroline Nolan, 210 Shore Road, Portaferry, Co. Down objecting to Eirgrid's proposals to erect pylons in the County Carlow area.
